



**PERMIT TO ALLOW RESEARCH USE AND SUPPLY
OF AN AGVET CHEMICAL PRODUCT**

PERMIT NUMBER -PER10944

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a Supplier (as indicated) to possess the product for the purposes of supply and to supply the product to a person who can use the product under permit. This permit also allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder, the Supplier (if not one and the same) and any person stipulated below to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Product to be used:

INTERCEPT 480SL TURF GROWTH REGULATOR

Containing:480 g/L ETHEPHON as its only active constituent.

Directions for Use:

Apply in accordance with all directions as contained in the label at Attachment 1.

Jurisdiction:

ALL States.

Additional Conditions:

- PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.

Supply and record keeping:

- The supplier must supply the product in a container that complies with the requirements of section 18(1) of the Agricultural and Veterinary Chemicals Code Regulations. Attached to this container must be a label which is identical in content and format to the label in Attachment 1.
- The permit holder or supplier must not supply an amount of product that exceeds the quantity stated in this permit required to treat any nominated area. A receipt for each supply must include details of the person/s, quantity of product, area to be treated and date when supply occurred.
- The permit holder or supplier must at the time of the supply of the product provide to the person a copy of the permit in full setting out the conditions and/or instructions for use or schedule to the permit approved by the APVMA that sets out the conditions and/or instructions for use.
- This permit allows only the person or company listed as the Supplier to possess the product for the purposes of supply and to supply the product to a person who can use the product under the conditions of this permit.
- The permit holder may only publish notices to call for persons to participate in the approved research. Publishing a notice by any means offering to supply the product is an offence against the Agvet Code and not exempted by issue of this permit.
- The permit holder must maintain records of the research performed under this permit. Specifically details must include the date and location where the trials were conducted, commodities treated, rates and frequency of application, total amount of product used and the names and addresses of the persons conducting the research and confirmation that at the time of supply of the product a copy of the permit was provided to them in full setting out the conditions and/or instructions for use or schedule to the permit approved by the APVMA that sets out the conditions and/or instructions for use. These details must be maintained for a minimum period of two years from the date of expiry of this permit and must be made available to the APVMA upon request.

- The records regarding persons, amount of product supplied, commodities to be treated, hectares to be treated and confirmation that at the time of supply of the product a copy of the permit in full setting out the conditions and/or instructions for use or schedule to the permit approved by the APVMA that sets out the conditions and/or instructions for use was provided to them must be made at the time of supply of the chemical product. Details of the amount of product used, rates and frequency of application must be made within 7 days of the permit holder becoming aware.

Maximum Area to be Treated:

- The maximum area that can be treated under this permit is 40 hectares.

Maximum Amount of Product to be Supplied:

- The maximum quantity of product that can be supplied under this permit is 2,400L.

DIRECTIONS FOR USE

RESTRAINTS

DO NOT re-apply Intercept 480SL within 2 weeks of the initial application.

DO NOT apply multiple applications of Intercept in areas where excessive thatch has accumulated.

DO NOT mix Intercept with Ammonium Thiosulphate.

DO NOT exceed a maximum of Intercept of 42L/ha per year.

For use in all States where appropriate for the crop and/or pest.

A period of 2-3 weeks after application is required for maximum seed head suppression performance. A repeat application is required in 14 – 21 days. Tank Mixtures of Intercept and Primo Maxx at 400mL/ha can be used to promote seedhead suppression as well as turfgrass quality. Application of this mixture during frost periods may cause temporary turf discolouration. |

GENERAL INSTRUCTIONS

Mixing

Half fill the spray tank with water, add the required amount of product, then the remainder of water and mix well. **DO NOT** use alkaline water.

Equipment

This product is corrosive to metals. Mix only the quantity of spray required for immediate use and do not allow to stand in metal containers for more than 2 hours. Flush equipment thoroughly with water after use.

PROTECTION OF CROPS, NATIVE AND OTHER NON-TARGET PLANTS

DO NOT apply under weather conditions or from spraying equipment that could be expected to cause drift onto nearby plants and adjacent crops, crop-lands or pasture. Wash sprayer thoroughly after use.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

DO NOT spray while bees are foraging in the vicinity to avoid potential risks to bees.

STORAGE AND DISPOSAL

Store in the closed original container in a dry, cool, well-ventilated area, out of direct sunlight.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specially marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS

Product is harmful if swallowed. Attacks the eyes. Protect while using. Repeated minor exposure may have a cumulative poisoning effect. Obtain an emergency supply of atropine tablets (0.6mg). When preparing the spray and using the prepared spray wear cotton overalls buttoned to the neck and wrist, elbow length PVC gloves and face shield or goggles. Wash hands after use. After each day's use wash gloves, face shield or goggles and contaminated clothing.

RE-ENTRY

DO NOT allow entry into treated areas for a minimum of 1 hour following application. If prior entry is required where personal protective equipment as outlined above.

FIRST AID
